## **General Terms and conditions:**

- The tender should be supported with GST registration certificate with latest GST return. The tenders are required to be submitted online accompanied with an earnest money of Rs 20000/- in the shape of CDR and cost of tender of Rs. 1000/-pledged to Secretary/CEO, J&K Khadi and Village Industries Board Jammu payable at Jammu, otherwise tender will not be entertained. No interest would be payable on Earnest Money deposited with the Department. The tenders not accompanied with required Earnest Money and Tender Fee shall be out rightly rejected.
- 2) Successful tenderer shall have to install pandal and allied equipments as per the dates mentioned on work order for allotment to concerned unit holders and shall have to execute an agreement with the Board for installation of pandal and fabrication of stalls, equipment and its maintenance during exhibition period to ensure successful organization of event.
- The agency should be registered with Central/J & K State Government and must submit the details of their Registration, Income Tax Registration, copy of PAN Card, GST number and other related documents.
- 4) The tenderer must submit the experience certificate of holding such type of event not below 10 Lakhs.
- 5) Outsourcing or subletting of any nature or third party would not be accepted.
- In case of failure of tenderer to do job successfully and satisfactorily, earnest money will be forfeited and job will be got completed from other agencies at his risk and cost. He shall be also blacklisted for participation in similar events by KVI Board in future.
- 7) Committee constituted for arrangement of Exhibition shall have discretion of accepting or rejecting any tender without assigning any reason.
- 8) Rates shall be quoted inclusive of all taxes/GST. The rates quoted shall be inclusive of costs i.e installation, lighting and electric charges, to and fro handling and transportation charges besides cost of other events and items, security insurance etc. mention above.

- 9) Printing work of text and pictures for advertisement must be legible and clean.
- 10) The Agency should give an undertaking in writing that it has not been blacklisted by any Central/State Government/Autonomous/Recruitment/Examining Body.
- 11) The decision of Secretary/CEO, J& K KVIB (Chairman NSSH Organizing Committee) shall be the final and binding upon the bidders in the event of any dispute arising out of the terms of the contract.
- The payment shall be released to the tenderer after satisfactory completion of the job. No payment shall be made in advance. Income Tax as per relevant rules shall be deducted at source and with regard to other taxes compliances as per rules applicable; party/agency shall be personally responsible.
- 13) Level of stalls has to be raised by 6 inches from ground & stalls shall have to be made water proof keeping in view expected weather inclemency.
- 14) Successful bidder shall ensure compliance to all the safety and security measure notified by the Central and State government from time to time for organizing such type of events i.e. arranging sufficient fire extinguisher, proper service gates etc.
- 15) Successful bidder shall also arrange the lodging and boarding facility for the participants.
- Successful bidder shall ensure the proper availability of water in the premises during the entire Exhibition period.
- 17) Insurance cover of at least Rs 50 lacs for the products of stalls shall be covered by the vendor.
- Successful bidder shall ensure proper security arrangements 24\*7 and also at least 6 security guards shall be there during the entire Exhibition period.
- 19) Successful bidder shall strictly follow Standard Operation Procedures (SOPs) during the entire event to prevent transmission of COVID-19 as per the guidelines issued from time to time by the Government.
